



Business Progress Report

In line with previous coordination and our plan to continue our startup project focused on the production of waste treatment and sanitization devices for livestock, we would like to report the following updates and progress made so far:

1. Obtaining Business Number: The Business Number for our startup has been obtained as the first step towards initiating official activities, enabling us to officially track and record all operations.

2. Opening a Company Bank Account: To better manage financial resources and control transactions related to the project, an official bank account for the company has been opened in Canada.

3. Review and Analysis of Industrial Areas for Workshop Leasing:

- **Zoning Regulations Review:** Necessary information about zoning regulations in Winnipeg's industrial areas has been collected.
- **Study of Winnipeg Industrial Zones:** Several industrial areas, including St. Boniface, St. James Brooklands – Weston, Point Douglas, Transcona – Springfield, and Inkster, have been reviewed. Due to their strategic location and accessibility to transportation facilities, these areas are considered suitable options for establishing the workshop. The final decision is yet to be made as further consultations continue.

4. Analysis of Workplace Safety and Health Standards: In cooperation with the WSH organization, we conducted preliminary assessments regarding the safety requirements for installing and operating the devices, including ventilation, safe access, and fire control.

5. Study of Environmental and Waste Management Requirements: In line with environmental regulations and pollution reduction objectives, we contacted Manitoba's Ministry of Environment, Climate, and Parks (MECP) and gathered the necessary information on odor control, safe waste management, and pollutant treatment.

6. Consultation and Information Gathering for Construction and Installation Permits: We have received the relevant details on installation and operational requirements from the Winnipeg Building Regulations Office and are planning to submit permit applications soon.

7. Estimation of Costs and Required Documents for Permits: The required documents for permit applications, including the business plan, identity documentation, and lease documents, have been collected, and financial estimates related to this process have been completed.
